#### Mission Statement

The mission of the North Dakota Community Foundation is to improve the quality of life for North Dakota's citizens through charitable giving and promoting philanthropy.

## About the North Dakota Community Foundation

The North Dakota Community Foundation was incorporated in 1976. NDCF is an IRS designated 501(c)(3) statewide public nonprofit tax-exempt corporation that receives and distributes charitable funds to support a wide range of programs that benefit North Dakotans.

NDCF was formed by a group of concerned citizens who were looking for a general charitable vehicle to build endowment to support the nonprofit sector in the state. Initial support for the Foundation came from the Otto Bremer Foundation, the Northwest Area Foundation, the Northwest Bancorporation, the North Dakota Bremer Banks and the Bush Foundation.

The office staff under the supervision of its volunteer Board of Directors carries out the work of the Foundation. Board members represent all citizens of North Dakota. All grant distribution decisions are made by the NDCF Board of Directors.

### National Standards

The National Standards Seal represents official confirmation from the Community Foundations National Standards Board that NDCF has met the most rigorous standards for community foundations. The seal affirms



NDCF's commitment to financial security, transparency, and accountability and says that our grantmaking includes an open, competitive process designed to address the changing needs of our community.

## NDCF Board of Directors

NDCF is governed by a 15-member Board of Directors. They are volunteers and receive no financial compensation for their service on the Board. They are elected from the population of North Dakota and are selected to represent a broad cross-section of North Dakotans. They can serve two three-year terms and then must leave the Board. This structure ensures that the North Dakota Community Foundation is truly the people of North Dakota's Foundation.

## Chair & President's Letter

Your dedication and commitment to North Dakota and its citizens is impressive. Because of you - our donors and volunteers all across the state - NDCF has grown substantially in the last three years. In fact, our total assets have increased by 50% since 2012 – you can see our growth chart on page 6. We currently manage about 600 charitable funds – an increase of 23% since 2012.

In order to maintain and increase our level of service to our local community foundations, scholarship funds, agency endowments, donor-advised funds, fiscal sponsorships and grantees, we have had to add 3 new staff to keep up with the pace you have set for us.

So, whom did we add and why? We opened an office in Dickinson and hired John Heinen as our third development director. We have added several local community foundations in the last few years (we currently have 61 local community foundations under our umbrella) and our development directors act as their paid "staff" person. We now have John in the west, Kara Geiger covering central North Dakota and Amy Warnke working out of our Grand Forks office assisting our foundations in the east.


Juanita Clayton joined us in October and serves as our Office Manager. Previously, our accountant was responsible for both accounting and office management duties. Our growth has necessitated that we split the accounting function and the office management function. We hired Sarah Guss as our new staff accountant earlier this year. With this increased capacity, our goal is to maintain and improve our responsiveness and our operating efficiency.

We brought Christi Stonecipher on board as full-time Director of Communications on January 1, 2016. She had contracted with us on a part-time basis for three years prior. She has increased and improved communications with our volunteers, donors, and partners so that you know what "your" community foundation is doing. NDCF is the people of North Dakota's Foundation – our job is to help you do good work in your community and region.

You can see all of our staff on page 7. Please know that every one of them is dedicated to our mission – improving the quality of life for North Dakota's citizens – and will help you in any way they can to accomplish that.

Lest you think that we are "overstaffed" let us tell you about a conversation Kevin had last summer with one of his colleagues who runs a statewide community foundation nearly identical in size. She called to ask advice regarding their staffing needs. They were going to add 3.5 more employees for a total of 14 staff. Our answer was that we were probably the wrong community foundation to ask as we were just planning to add staff to get to 7! The moral of the story is that even at 7 full time employees, we are quite lean compared to others in the community foundation world. That is because we partner with local volunteers and community leaders all across North Dakota to help accomplish our mutual goals.

These additions and changes are part of an impressive growth pattern and allow us to keep pace with the demand for our work. This annual report gives you a snapshot of what we together accomplished last year all across North Dakota. We are proud to partner with all of you in making North Dakota a better place to live, work, and play.




Over 1,250 different individuals and businesses . . . who gave \$12,257,179 to NDCF funds in 2015 to improve the lives of our residents.



#### Statewide Greatest Needs Fund

NDCF's Statewide Greatest Needs Fund provides grant dollars for projects and programs across the state that make a significant difference in the quality of life of area residents. For some communities, NDCF's Statewide Greatest Needs Fund is the only funding source they have to help them make improvements in their town.

NDCF's Board of Directors reviews grant applications once a year and determines grant awards. NDCF was pleased to award \$124,500 in 2015 to 37 organizations, including those shown here:




#### **New Community Foundations**



## ND Association of Rural Electric Coop.

The ND Association of Rural Electric Cooperatives (NDAREC), Basin Electric, Capital Electric, Mor-Gran-Sou Electric Cooperative, and CoBank, a national cooperative bank, joined forces to donate \$65,000 in September to the BisMan Community Foundation, an endowment fund established in 2011 through NDCF benefitting the Bismarck/Mandan area.

NDCF had previously arranged a matching grant with the Otto Bremer Trust so the \$65,000 donation was matched dollar-for-dollar, for a total contribution of \$130,000.

Dennis Hill, executive vice president and general manager of NDAREC, said it was a natural fit for the cooperatives to combine donations and support the BisMan Community Foundation.

"Electric cooperatives are all about providing services and support in a variety of ways to improve their member-owners' quality of life. That's what community foundations are about, as well," Hill says. "As corporate citizens, we agreed that we should support this foundation as it aligns with our goals of building strong, vibrant communities in which our member-owners and our employees live and work."

Local businesses are key partners in NDCF's community funds, often leading the way in donations and/or providing matching funds for their local committee's fundraising efforts.

## The Power of Endowment

An endowment fund is a permanent financial resource that provides annual grants to support a specific community, charity, or school forever. The chart below illustrates the power of endowment based on NDCF's actual net investment performance from 1990 through 2015.

Let's say Bob started a permanent endowment fund with NDCF in 1990 with \$100,000 and never invested another penny in the fund. On December 31, 2015, Bob's endowment fund would have a **total balance of \$145,264.19**. The chart shows the balance of the fund every year based on actual NDCF portfolio performance.

Support each year – his local library or a summer arts camp for kids or the effort to build a new hockey arena in his hometown.

(This example assumes that 4% of the balance was given out as grants and a small administrative fee was paid every year from the fund.)




This is Bob – he's really a nice guy. You should hang out with him sometime.

Even if no additional money is ever contributed to Bob's fund, it will continue to make annual grants of roughly \$6,000 to support the charitable cause for which it was designed into perpetuity. This is the power and the beauty of endowment — recurring cash flow to support a community, a specific charity, or scholarship awards forever.



Endowment funds can be particularly powerful when a group of people all contribute to the same fund; pooling their donations in this way can grow the endowment fund into a significant resource for the cause it supports. # North Dakota Income Tax Credit Encourages Gifts To Endowment

An endowment fund is a permanent asset, which benefits the community, organization, or charitable purpose for which it was established into perpetuity. In order to encourage donations to qualified North Dakota endowment funds, which will support our residents forever in a variety of ways, the North Dakota Century Code allows for several generous state tax credits:

• Gifts by individuals to qualified ND endowment funds are allowed a ND income tax credit of 40% of the gift up to a \$10,000 credit per taxpayer. The individual must give at least \$5,000 in a tax year to a single endowment fund in order to qualify



for the credit (Credit may be carried forward for three additional tax years). This means that a \$5,000 gift may have the same out-of-pocket actual cost as a \$2,222 gift (but with a much greater impact to the endowment fund!).

- Businesses receive a ND income tax credit equal to 40% of any gift size to a qualified ND Endowment Fund up to a maximum credit of \$10,000 per taxpayer (Credit may be carried forward for three additional tax years).
- Individuals who establish a qualified deferred gift with a ND charitable organization receive a 40% ND income tax credit for the deductible portion of the gift up to \$10,000 per taxpayer (Credit may be carried forward for three additional tax years).

Your gift of \$5,000 to one of the NDCF's qualified endowment funds is not only tax deductible on your federal income tax return, it should also qualify for a 40% or \$2,000 credit against your ND income tax liability. If you are in the 30% federal income tax bracket, the net cost of your \$5,000 gift could be as low as \$1,500 after taking the federal and ND income tax benefits into account. If you cannot use all of your ND income tax credit in one year, you may carry it forward for an additional 3 years.

As the above illustrates, this law creates wonderful incentives for North Dakota taxpayers to give back to qualified ND charitable endowment funds. Please contact us to discuss how you can work with the NDCF to carry out your charitable dreams and benefit from this fantastic tax incentive.

## How to Start a Fund at NDCF

You don't have to be a millionaire to be a philanthropist!

You can contribute to any of the existing funds at NDCF or you can create a fund to benefit the areas you want to support. Here's what you do:

1. Determine the type of fund you want to start.

Community Endowment Fund: This permanent, flexible resource for your hometown will provide grant money every year for whatever is most important to the community at that time. Grant recommendations are made by a local volunteer advisory committee who also fundraise so the fund continues to grow in the future.

**Donor-Advised Fund:** Establish a donor-advised fund at NDCF and recommend how grants from your fund can address the needs you feel are most important in North Dakota.

School Foundation: Want to support your alma mater? Establish a fund for your high school (or elementary school!) and make sure that future generations of scholars have the tools they need to succeed. Your fund can be non-endowment (for immediate needs) or endowment (to provide long-term resources), or both.

**Field of Interest:** Select a focus area (for example, "the arts" or "senior citizens") and either recommend grants from the fund yourself or allow the NDCF Board of Directors to make grants according to your general guidelines.

**Named Fund:** Create a fund in your name to support the specific community or charity or organizations you wish to help.

**Scholarship Fund:** Help students further their education with a scholarship fund that includes your criteria for awards.

- 2. Choose the name of your fund.
- 3. Sign the agreement and make your initial gift.

Yes, it's really that easy.
